## Admission of observers: organizations applying for admission as observers

### Note by the secretariat

1. The admission of intergovernmental organizations (IGOs) and non-governmental organizations (NGOs) as observers at sessions of the Conference of the Parties (COP) is governed by Article 7, paragraph 6, of the Convention, which provides that, inter alia:

“Any body or agency, whether national or international, governmental or non-governmental, which is qualified in matters covered by the Convention, and which has informed the secretariat of its wish to be represented at a session of the Conference of the Parties as an observer, may be so admitted unless at least one third of the Parties present object.”

2. COP 1 agreed<sup>1</sup> that the secretariat should invite to the future sessions of the COP all IGOs and NGOs admitted at COP 1 and at future sessions unless an objection was raised to any particular organization in accordance with the Convention and the draft rules of procedure being applied.<sup>2</sup> Consequently, the secretariat has notified all organizations admitted to previous sessions of the COP (with the exception of those admitted to a single session only) of the date and venue of COP 30 in accordance with rule 8 of the draft rules of procedure being applied, without prejudging decisions that may be taken by the COP. Only new applicants need to apply for admission.

3. The secretariat has prepared, for consideration by the COP, a list of new applicant NGOs (see annex I) that have expressed a wish to be represented at sessions of the COP as observers and satisfy the requirements set out in (1) the Convention, (2) the draft rules of procedure being applied and (3) established practice. No IGOs submitted eligible applications.

4. In drawing up the list, the secretariat has taken due account of the provisions of Article 7, paragraph 6, of the Convention and rules 7–8 of the draft rules of procedure being applied, as well as of established practice, of which the Subsidiary Body for Implementation took note,<sup>3</sup> whereby IGOs and NGOs are required to provide proof of competence in matters related to the Convention and to confirm their independent juridical personality and non-profit and/or tax-exempt status in a Member State of the United Nations, of one of its specialized agencies or of the International Atomic Energy Agency, or in a State party to the Statute of the International Court of Justice.

5. While the secretariat was unable to confirm the full compliance of the 17 organizations from the host country of COP 30 listed in annex II with the requirements

referred to in paragraph 3 above, the secretariat has prepared the list to be considered by the COP for admission to COP 30 only with a view to ensuring the adequate representation of observer organizations from the host country at that session. This follows past practice,<sup>4</sup> where organizations from host countries that were not recommended for admission as observers at all future UNFCCC sessions were admitted for a specific session.

6. Annex III provides details of admitted observer organizations that notified the secretariat they had legally changed their name as a result of rebranding or merging with another organization during the reporting period, between July 2024 and May 2025. In such instances, organizations are required to provide information in line with the aforementioned established practice and were deemed qualified to maintain observer status under their new name.

7. The members of the Bureau received the lists of new applicants for their review and agreed to recommend the organizations listed to the COP for admission. These organizations have been advised of their provisional admittance status on the understanding that the final authority for their admission as observers rests with the COP. COP 30 is invited, at its 1<sup>st</sup> meeting, to accord observer status to the NGOs listed in annex I, to accord observer status for COP 30 only to the NGOs listed in annex II and to note the name changes of the admitted observers listed in annex III.

8. With respect to rules 6–7 of the draft rules of procedure being applied, a single process is to be used for the admission of observer organizations to sessions of the COP, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol<sup>5</sup> and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement,<sup>6</sup> with decisions on the admission of observer organizations being taken by the COP.
